THIS METHOD IS LIMITED TO WAGES WITHIN CERTAIN RANGES AND IS SUITABLE FOR EMPLOYERS WHO PREFER A QUICK REFERENCE APPROACH WITHOUT COMPLEX CALCULATIONS.

PERCENTAGE METHOD

THE PERCENTAGE METHOD IS MORE FLEXIBLE AND SUITABLE FOR HIGHER WAGES OR VARIABLE PAY PERIODS. IT INVOLVES CALCULATING WITHHOLDING BASED ON A PERCENTAGE APPLIED TO WAGES EXCEEDING SPECIFIED THRESHOLDS AFTER ACCOUNTING FOR WITHHOLDING ALLOWANCES.

THIS METHOD IS PREFERRED WHEN WAGE AMOUNTS EXCEED THE LIMITS OF THE WAGE BRACKET TABLES OR WHEN EMPLOYERS REQUIRE PRECISE WITHHOLDING FOR COMPLEX PAYROLL SCENARIOS.

CHOOSING THE APPROPRIATE METHOD
