EACH TYPE OF WASTE IS HANDLED ACCORDING TO ESTABLISHED PROTOCOLS TO ENSURE SAFETY AND ENVIRONMENTAL PROTECTION.

## OPERATIONAL HOURS AND ACCESS

THIS GAS CAN BE PROCESSED FOR ENERGY RECOVERY OR SAFELY FLARED TO REDUCE GREENHOUSE GAS EMISSIONS.

## SUSTAINABLE PRACTICES

THE ATASCADERO DUMP SITE EMPHASIZES SUSTAINABLE WASTE MANAGEMENT BY ENCOURAGING WASTE REDUCTION, REUSE, AND RECYCLING.
