WHO USES THE CONSTRUCTION SOV?

KEY COMPONENTS OF A CONSTRUCTION SOV

HOW TO PREPARE A CONSTRUCTION SOV

PREPARING AN EFFECTIVE CONSTRUCTION SCHEDULE OF VALUES REQUIRES CAREFUL PLANNING AND KNOWLEDGE OF THE PROJECT SCOPE. THE PROCESS INVOLVES SEVERAL STEPS TO ENSURE ACCURACY AND COMPLIANCE WITH CONTRACT REQUIREMENTS.

REVIEW CONTRACT DOCUMENTS

UPDATE REGULARLY
