OVERVIEW OF CORAL SPRINGS BUSINESS TAX

THE CORAL SPRINGS BUSINESS TAX SYSTEM IS DESIGNED TO GENERATE REVENUE FROM COMMERCIAL ACTIVITIES CONDUCTED WITHIN THE CITY LIMITS. THIS TAX FRAMEWORK SUPPORTS MUNICIPAL SERVICES, INFRASTRUCTURE, AND COMMUNITY PROGRAMS THAT BENEFIT LOCAL BUSINESSES AND RESIDENTS. OCCUPATIONAL LICENSE FEES

IN ADDITION TO THE BASIC BUSINESS TAX RECEIPT, SOME PROFESSIONS REQUIRE OCCUPATIONAL LICENSES THAT FUNCTION AS SPECIALIZED BUSINESS TAXES. THESE FEES APPLY TO REGULATED INDUSTRIES SUCH AS HEALTHCARE PROVIDERS, CONTRACTORS, AND FOOD SERVICE ESTABLISHMENTS.

COMMERCIAL PROPERTY TAXES

BUSINESSES OWNING COMMERCIAL REAL ESTATE IN CORAL SPRINGS ARE ALSO RESPONSIBLE FOR PAYING PROPERTY TAXES ASSESSED BY THE CITY AND COUNTY. THESE TAXES ARE CALCULATED BASED ON PROPERTY VALUE AND ARE SEPARATE FROM BUSINESS TAX RECEIPTS.

SALES AND USE TAXES

WHILE SALES TAXES ARE ADMINISTERED AT THE STATE LEVEL BY FLORIDA, CORAL SPRINGS BUSINESSES MUST COLLECT AND REMIT APPLICABLE SALES TAXES ON GOODS AND SERVICES SOLD. USE TAXES MAY ALSO APPLY TO TAXABLE ITEMS PURCHASED WITHOUT SALES TAX PAID AT THE POINT OF SALE.

BUSINESS TAX FILING REQUIREMENTS

REGISTRATION PROCESS
