OVERVIEW OF DES MOINES WASTE MANAGEMENT SERVICES

DES MOINES WASTE MANAGEMENT IS ADMINISTERED THROUGH A COMBINATION OF MUNICIPAL DEPARTMENTS AND CONTRACTED SERVICE PROVIDERS. THE CITY'S APPROACH EMPHASIZES EFFICIENT, RELIABLE WASTE COLLECTION AND ENVIRONMENTALLY RESPONSIBLE DISPOSAL METHODS. THESE SERVICES ARE DESIGNED TO ADDRESS THE NEEDS OF DIVERSE USERS, INCLUDING SINGLE-FAMILY HOMES, MULTI-UNIT RESIDENCES, BUSINESSES, AND PUBLIC INSTITUTIONS. CORE WASTE MANAGEMENT OPERATIONS INCLUDE CURBSIDE PICKUP, RECYCLING PROCESSING, LANDFILL MANAGEMENT, AND PUBLIC EDUCATION ON WASTE REDUCTION.

MUNICIPAL WASTE COLLECTION INFRASTRUCTURE

THE CITY OF DES MOINES OPERATES A STRUCTURED WASTE COLLECTION SYSTEM THAT SCHEDULES REGULAR PICKUPS FOR RESIDENTIAL AND COMMERCIAL CUSTOMERS. COLLECTION TRUCKS ARE EQUIPPED TO HANDLE DIFFERENT WASTE STREAMS SUCH AS GENERAL TRASH, RECYCLABLES, AND YARD WASTE. THE INFRASTRUCTURE ALSO INCLUDES TRANSFER STATIONS WHERE WASTE IS TEMPORARILY HELD BEFORE BEING TRANSPORTED TO FINAL DISPOSAL SITES. THIS SYSTEM ENSURES TIMELY AND EFFICIENT WASTE REMOVAL WHILE MINIMIZING ENVIRONMENTAL DISTURBANCES.

CONTRACTED WASTE SERVICES

IN ADDITION TO MUNICIPAL OPERATIONS, DES MOINES CONTRACTS WITH PRIVATE WASTE MANAGEMENT COMPANIES TO SUPPLEMENT SERVICE CAPACITY AND SPECIALIZED WASTE HANDLING. THESE CONTRACTS ALLOW THE CITY TO MAINTAIN FLEXIBILITY AND RESPONSIVENESS IN WASTE COLLECTION, RECYCLING, AND DISPOSAL. CONTRACTED SERVICES OFTEN INCLUDE HAZARDOUS WASTE COLLECTION EVENTS, BULK ITEM PICKUPS, AND COMMERCIAL WASTE MANAGEMENT SOLUTIONS TAILORED TO VARIOUS INDUSTRIES.

RESIDENTIAL WASTE COLLECTION AND RECYCLING PROGRAMS

RESIDENTIAL WASTE MANAGEMENT IN DES MOINES IS DESIGNED TO PROMOTE CONVENIENCE AND ENVIRONMENTAL RESPONSIBILITY AMONG HOUSEHOLDS. THE CITY OFFERS COMPREHENSIVE CURBSIDE COLLECTION PROGRAMS THAT SEPARATE WASTE INTO TRASH, RECYCLABLES, AND YARD WASTE. PUBLIC PARTICIPATION IN THESE PROGRAMS IS CRITICAL TO ACHIEVING WASTE DIVERSION

GOALS AND REDUCING LANDFILL DEPENDENCE.

CURBSIDE TRASH AND RECYCLING PICKUP

DES MOINES RESIDENTS RECEIVE WEEKLY CURBSIDE TRASH COLLECTION, WITH RECYCLABLES COLLECTED BIWEEKLY OR WEEKLY DEPENDING ON THE NEIGHBORHOOD. ACCEPTED RECYCLABLE MATERIALS TYPICALLY INCLUDE PAPER, CARDBOARD, PLASTICS MARKED WITH SPECIFIC RECYCLING CODES, GLASS CONTAINERS, AND METALS. THE CITY ENCOURAGES PROPER SORTING TO REDUCE CONTAMINATION RATES AND IMPROVE THE EFFICIENCY OF RECYCLING PROCESSING FACILITIES.

YARD WASTE AND COMPOSTING SERVICES

SEASONAL YARD WASTE COLLECTION IS A KEY COMPONENT OF DES MOINES WASTE MANAGEMENT, HELPING TO DIVERT ORGANIC MATERIAL FROM LANDFILLS. RESIDENTS CAN PLACE GRASS CLIPPINGS, LEAVES, BRANCHES, AND OTHER YARD DEBRIS IN DESIGNATED CONTAINERS OR BAGS FOR PICKUP DURING SCHEDULED PERIODS. ADDITIONALLY, COMPOSTING INITIATIVES AIM TO CONVERT ORGANIC WASTE INTO NUTRIENT-RICH SOIL AMENDMENTS, SUPPORTING SUSTAINABLE LANDSCAPING PRACTICES WITHIN THE COMMUNITY.

RECYCLING EDUCATION AND OUTREACH

EDUCATIONAL PROGRAMS AND OUTREACH EFFORTS ARE CRITICAL TO INCREASING RECYCLING PARTICIPATION. DES MOINES REGULARLY PROVIDES INFORMATIONAL MATERIALS, WORKSHOPS, AND COMMUNITY EVENTS TO INFORM RESIDENTS ABOUT PROPER WASTE SORTING, THE BENEFITS OF RECYCLING, AND WAYS TO REDUCE WASTE GENERATION. THESE INITIATIVES FOSTER A CULTURE OF ENVIRONMENTAL STEWARDSHIP THROUGHOUT THE CITY.

COMMERCIAL AND INDUSTRIAL WASTE SOLUTIONS

DES MOINES WASTE MANAGEMENT EXTENDS TO COMMERCIAL AND INDUSTRIAL SECTORS THAT GENERATE SIGNIFICANT VOLUMES OF WASTE REQUIRING SPECIALIZED HANDLING. THE CITY COLLABORATES WITH BUSINESSES TO IMPLEMENT EFFECTIVE WASTE REDUCTION, RECYCLING, AND DISPOSAL STRATEGIES THAT COMPLY WITH REGULATORY REQUIREMENTS AND SUPPORT SUSTAINABILITY GOALS.

COMMERCIAL WASTE COLLECTION SERVICES

COMMERCIAL ESTABLISHMENTS IN DES MOINES HAVE ACCESS TO TAILORED WASTE COLLECTION SERVICES THAT ACCOMMODATE THEIR SPECIFIC OPERATIONAL NEEDS. THESE SERVICES INCLUDE REGULAR PICKUP OF GENERAL WASTE, RECYCLABLES, AND BULKY ITEMS. WASTE CONTAINERS ARE AVAILABLE IN VARIOUS SIZES AND CONFIGURATIONS TO OPTIMIZE ONSITE WASTE HANDLING AND STORAGE.

INDUSTRIAL WASTE MANAGEMENT AND COMPLIANCE

INDUSTRIAL FACILITIES OFTEN PRODUCE WASTE STREAMS THAT REQUIRE ADHERENCE TO STRICT ENVIRONMENTAL REGULATIONS, INCLUDING HAZARDOUS MATERIALS AND BYPRODUCTS. DES MOINES WASTE MANAGEMENT PROGRAMS PROVIDE GUIDANCE, PERMITS, AND MONITORING TO ENSURE THAT INDUSTRIAL WASTE IS PROPERLY MANAGED TO PREVENT ENVIRONMENTAL CONTAMINATION AND HEALTH RISKS.

PROTECT PUBLIC HEALTH AND THE ENVIRONMENT. THESE WASTE TYPES REQUIRE CAREFUL HANDLING, STORAGE, AND TREATMENT TO MITIGATE RISKS ASSOCIATED WITH TOXICITY, FLAMMABILITY, OR CHEMICAL REACTIVITY.

HOUSEHOLD HAZARDOUS WASTE COLLECTION

DES MOINES PERIODICALLY HOSTS HOUSEHOLD HAZARDOUS WASTE (HHW) COLLECTION EVENTS WHERE RESIDENTS CAN SAFELY DISPOSE OF ITEMS SUCH AS PAINTS, SOLVENTS, PESTICIDES, BATTERIES, AND ELECTRONICS. THESE EVENTS HELP PREVENT HAZARDOUS MATERIALS FROM ENTERING THE REGULAR WASTE STREAM OR THE ENVIRONMENT.

ELECTRONIC WASTE RECYCLING

ELECTRONIC WASTE (E-WASTE) INCLUDES DISCARDED ELECTRONIC DEVICES THAT OFTEN CONTAIN HAZARDOUS SUBSTANCES. THE CITY FACILITATES E-WASTE RECYCLING PROGRAMS THAT ENSURE RESPONSIBLE RECOVERY AND DISPOSAL OF COMPONENTS, REDUCING LANDFILL BURDEN AND ENCOURAGING THE REUSE OF VALUABLE MATERIALS.

SPECIAL WASTE HANDLING PROCEDURES

SPECIAL WASTE CATEGORIES, INCLUDING MEDICAL WASTE, CONSTRUCTION DEBRIS, AND LARGE APPLIANCES, ARE MANAGED THROUGH DESIGNATED PROTOCOLS. LICENSED FACILITIES AND SERVICE PROVIDERS IN DES MOINES ARE EQUIPPED TO HANDLE THESE WASTES IN COMPLIANCE WITH ENVIRONMENTAL STANDARDS, ENSURING SAFE AND EFFECTIVE DISPOSAL.

ENVIRONMENTAL IMPACT AND SUSTAINABILITY INITIATIVES

GREENHOUSE GAS REDUCTION STRATEGIES

WASTE MANAGEMENT ACTIVITIES CAN GENERATE METHANE AND OTHER GREENHOUSE GASES. DES MOINES IMPLEMENTS STRATEGIES SUCH AS LANDFILL GAS CAPTURE AND CONVERSION TO ENERGY, AS WELL AS PROMOTING ORGANIC WASTE COMPOSTING TO LOWER THE CITY'S OVERALL CARBON FOOTPRINT.

COMMUNITY ENGAGEMENT AND SUSTAINABILITY GOALS

THE CITY ENGAGES RESIDENTS, BUSINESSES, AND ORGANIZATIONS IN SUSTAINABILITY INITIATIVES THAT SUPPORT WASTE REDUCTION AND ENVIRONMENTAL STEWARDSHIP. DES MOINES HAS SET AMBITIOUS GOALS TO INCREASE RECYCLING RATES, REDUCE PER CAPITA WASTE GENERATION, AND ENHANCE PUBLIC AWARENESS OF SUSTAINABLE WASTE PRACTICES.

FUTURE DEVELOPMENTS IN DES MOINES WASTE MANAGEMENT

POLICY AND REGULATORY ENHANCEMENTS
