BACKGROUND ON RYAN WALTERS

ALLEGATIONS OF MISCONDUCT

THIS COULD INVOLVE ACCUSATIONS OF CORRUPTION, MISUSE OF PUBLIC FUNDS, OR UNETHICAL BEHAVIOR RELATED TO WALTERS' OFFICIAL RESPONSIBILITIES. TYPICAL PROCEDURES IN FBI INVESTIGATIONS

FBI INVESTIGATIONS GENERALLY FOLLOW A SYSTEMATIC APPROACH THAT INCLUDES:

- INITIATION BASED ON CREDIBLE ALLEGATIONS OR EVIDENCE
- COLLECTION OF DOCUMENTS, ELECTRONIC DATA, AND PHYSICAL EVIDENCE
- INTERVIEWS AND INTERROGATIONS OF WITNESSES AND SUSPECTS
- SURVEILLANCE AND UNDERCOVER OPERATIONS IF NECESSARY

- COORDINATION WITH FEDERAL PROSECUTORS FOR LEGAL ACTIONS

THIS RIGOROUS PROCESS ENSURES THAT INVESTIGATIONS ARE THOROUGH AND LEGALLY SOUND.

POTENTIAL OUTCOMES AND LEGAL IMPLICATIONS

OUTCOMES OF FBI INVESTIGATIONS CAN VARY WIDELY, INCLUDING:

- NO CHARGES IF INSUFFICIENT EVIDENCE IS FOUND
