TYPES OF FINANCIAL AID AVAILABLE

GRANTS

GRANTS ARE A FORM OF FINANCIAL AID THAT TYPICALLY DO NOT REQUIRE REPAYMENT. THEY ARE OFTEN AWARDED BASED ON FINANCIAL NEED AND CAN COME FROM FEDERAL, STATE, OR INSTITUTIONAL SOURCES. PENN STATE WORLD CAMPUS STUDENTS MAY QUALIFY FOR GRANTS SUCH AS THE FEDERAL PELL GRANT OR STATE-SPECIFIC GRANTS DEPENDING ON RESIDENCY AND ELIGIBILITY.

SCHOLARSHIPS

LOANS

LOANS PROVIDE STUDENTS WITH FUNDS THAT MUST BE REPAYED, USUALLY WITH INTEREST. PENN STATE WORLD CAMPUS SUPPORTS FEDERAL STUDENT LOANS AS WELL AS PRIVATE LOANS. IT IS IMPORTANT FOR STUDENTS TO UNDERSTAND THE TERMS

AND CONDITIONS OF THESE LOANS BEFORE BORROWING.

Work-Study Programs

WORK-STUDY IS A FEDERAL PROGRAM THAT ALLOWS ELIGIBLE STUDENTS TO EARN MONEY THROUGH PART-TIME EMPLOYMENT, HELPING TO COVER EDUCATIONAL EXPENSES. WHILE ON-CAMPUS JOBS MAY BE LIMITED FOR ONLINE STUDENTS, THERE ARE OPPORTUNITIES FOR REMOTE OR COMMUNITY-BASED WORK-STUDY POSITIONS.

Eligibility Requirements

UNDERSTANDING ELIGIBILITY CRITERIA IS ESSENTIAL FOR ACCESSING FINANCIAL AID AT PENN STATE WORLD CAMPUS. THESE REQUIREMENTS ENSURE THAT AID IS DISTRIBUTED FAIRLY AND TO THOSE STUDENTS WHO QUALIFY BASED ON NEED OR MERIT.

Enrollment Status

Satisfactory Academic Progress

MAINTAINING SATISFACTORY ACADEMIC PROGRESS (SAP) IS A REQUIREMENT TO CONTINUE RECEIVING FINANCIAL AID. THIS INCLUDES MAINTAINING A MINIMUM GPA AND SUCCESSFULLY COMPLETING A REQUIRED PERCENTAGE OF ATTEMPTED COURSEWORK.

Application Process for Financial Aid

FAFSA Submission

AWARD NOTIFICATION

WORK-STUDY OPPORTUNITIES
