TIMELINE OF CRIMES

DISTINGUISHING BETWEEN THESE SCENARIOS IS CRUCIAL TO MAINTAINING THE INTEGRITY OF THE INVESTIGATION AND ENSURING ACCURATE ATTRIBUTION OF EACH MURDER.

VICTIMOLOGY AND TARGET PROFILES

VICTIMOLOGY PLAYS A VITAL ROLE IN PROFILING THE HAMMOND SERIAL KILLER. BY EXAMINING THE DEMOGRAPHIC AND BEHAVIORAL CHARACTERISTICS OF THE VICTIMS, LAW ENFORCEMENT CAN INFER THE KILLER'S PREFERENCES AND MOTIVES.

COMMON VICTIM TRAITS

POTENTIAL REASONS FOR TARGET SELECTION

THE KILLER'S CHOICE OF VICTIMS MAY BE DRIVEN BY PSYCHOLOGICAL FACTORS, PAST TRAUMA, OR OPPORTUNISTIC BEHAVIOR. STUDYING THESE ELEMENTS HELPS CREATE A BEHAVIORAL PROFILE THAT CAN NARROW DOWN SUSPECT POOLS. FOR EXAMPLE, TARGETING MARGINALIZED INDIVIDUALS MIGHT REFLECT THE OFFENDER'S DESIRE FOR CONTROL AND DOMINANCE WITHOUT THE RISK OF QUICK DETECTION.

INVESTIGATION AND LAW ENFORCEMENT RESPONSE
