- **WINDSHIELD:** NON-REFLECTIVE TINTING IS ALLOWED ON THE UPPERMOST 6 INCHES OF THE WINDSHIELD ONLY.
- **FRONT SIDE WINDOWS:** MUST ALLOW AT LEAST 35% OF LIGHT TO PASS THROUGH (I.E., 35% VLT OR HIGHER).
- **REAR SIDE WINDOWS:** CAN HAVE A DARKER TINT WITH NO SPECIFIC VLT MINIMUM IN CERTAIN CASES.
- **REAR WINDOW:** MAY BE TINTED WITHOUT A SPECIFIC VLT REQUIREMENT IF THE VEHICLE HAS SIDE MIRRORS ON BOTH SIDES.

THESE CHANGES PROVIDE MORE FLEXIBILITY FOR REAR WINDOW TINTING WHILE MAINTAINING STRICTER STANDARDS FOR FRONT WINDOWS TO ENSURE VISIBILITY. THE LAW ALSO CLARIFIES THE MEASUREMENT PROCESS FOR TINT COMPLIANCE, SPECIFYING THE USE OF APPROVED LIGHT METERS AND TESTING METHODS TO VERIFY VLT PERCENTAGES.

REFLECTIVITY RESTRICTIONS

IN ADDITION TO VLT LEVELS, THE IOWA WINDOW TINT LAW CHANGE RESTRICTS THE REFLECTIVITY OF TINT FILMS. REFLECTIVE OR MIRRORED TINTS THAT COULD IMPAIR OTHER DRIVERS' VISION OR LAW ENFORCEMENT OBSERVATION ARE LIMITED TO A MAXIMUM OF 25% REFLECTANCE ON FRONT SIDE WINDOWS. THIS PROVISION AIMS TO PREVENT GLARE AND MAINTAIN ROAD SAFETY.

EXEMPTIONS AND SPECIAL CONSIDERATIONS

COMMERCIAL AND SPECIALTY VEHICLES

CERTAIN COMMERCIAL VEHICLES, LAW ENFORCEMENT VEHICLES, AND PASSENGER VEHICLES DESIGNED FOR SPECIFIC FUNCTIONS MAY HAVE DIFFERENT TINTING ALLOWANCES. FOR EXAMPLE, LIMOUSINES AND PASSENGER VANS USED FOR TRANSPORT MAY BE SUBJECT TO RELAXED TINT STANDARDS TO ENHANCE PASSENGER PRIVACY AND COMFORT.

OTHER CONSIDERATIONS

THE LAW ALSO ACCOUNTS FOR AFTERMARKET WINDOW TREATMENTS SUCH AS DECALS, SUNSHADES, OR TEMPORARY COVERINGS, PROVIDING GUIDELINES ON THEIR USE WITHOUT VIOLATING TINTING RESTRICTIONS.

ENFORCEMENT AND PENALTIES UNDER THE NEW LAW
