COMMON CAUSES OF CONSTRUCTION SITE INJURIES

STEPS TO TAKE AFTER A CONSTRUCTION SITE INJURY

FOLLOWING AN INJURY ON A CONSTRUCTION SITE, PROMPT AND APPROPRIATE ACTIONS CAN PROTECT LEGAL RIGHTS AND STRENGTHEN A POTENTIAL CLAIM. IMMEDIATE STEPS ARE CRUCIAL FOR DOCUMENTATION AND TREATMENT.

ESSENTIAL ACTIONS POST-INJURY
