IT OPERATES UNDER THE JURISDICTION OF THE COUNTY GOVERNMENT AND ADHERES TO STRICT PROTOCOLS TO ENSURE ACCURATE DETERMINATION OF CAUSE AND MANNER OF DEATH. THE OFFICE'S WORK IS INTEGRAL TO THE CRIMINAL JUSTICE SYSTEM, PUBLIC HEALTH MONITORING, AND PROVIDING CLOSURE TO BEREAVED FAMILIES.

HISTORY AND EVOLUTION

CAUSE AND MANNER OF DEATH DETERMINATION

THE CAUSE OF DEATH REFERS TO THE SPECIFIC INJURY OR DISEASE RESPONSIBLE, WHILE THE MANNER OF DEATH CATEGORIZES IT AS NATURAL, ACCIDENTAL, SUICIDE, HOMICIDE, OR UNDETERMINED.

DEATH INVESTIGATION AND SCENE EXAMINATION

FINAL DETERMINATION AND REPORTING

AFTER COMPLETING INVESTIGATIONS AND ANALYSES, THE MEDICAL EXAMINER ISSUES A DEATH CERTIFICATE SPECIFYING THE CAUSE AND MANNER OF DEATH. THESE REPORTS CAN BE CRITICAL IN LEGAL PROCEEDINGS AND PUBLIC HEALTH DATA COLLECTION.

AUTOPSY PROCEDURES AND FORENSIC PATHOLOGY

HOW DOES A MEDICAL EXAMINER DIFFER FROM A CORONER?

A MEDICAL EXAMINER IS A LICENSED PHYSICIAN, OFTEN A FORENSIC PATHOLOGIST, WHO PERFORMS AUTOPSIES, WHILE A CORONER IS TYPICALLY AN ELECTED OFFICIAL WHO MAY NOT HAVE MEDICAL TRAINING BUT OVERSEES DEATH INVESTIGATIONS.

WHAT QUALIFICATIONS ARE REQUIRED TO BECOME A MEDICAL EXAMINER CORONER?

QUALIFICATIONS USUALLY INCLUDE A MEDICAL DEGREE WITH SPECIALIZATION IN FORENSIC PATHOLOGY FOR MEDICAL EXAMINERS, WHILE CORONERS MAY REQUIRE A HIGH SCHOOL DIPLOMA OR A BACKGROUND IN LAW ENFORCEMENT, DEPENDING ON JURISDICTION.

WHY ARE MEDICAL EXAMINER CORONERS IMPORTANT IN THE JUSTICE SYSTEM?
