LEGAL AND ADMINISTRATIVE CONSEQUENCES

THESE PROGRAMS CAN INCLUDE COUNSELING SERVICES, STRESS MANAGEMENT WORKSHOPS, AND ACCESS TO CONFIDENTIAL ASSISTANCE FOR SUBSTANCE ABUSE ISSUES. EARLY INTERVENTION IS KEY TO PREVENTING INCIDENTS INVOLVING INTOXICATION.
