

# PLOS PUBLIC HEALTH IMPACT FACTOR

**PLOS PUBLIC HEALTH IMPACT FACTOR** IS A CRUCIAL METRIC FOR RESEARCHERS, ACADEMICS, AND INSTITUTIONS AIMING TO EVALUATE THE INFLUENCE AND PRESTIGE OF THE PLOS PUBLIC HEALTH JOURNAL WITHIN THE SCIENTIFIC COMMUNITY. ## UNDERSTANDING THE PLOS PUBLIC HEALTH IMPACT FACTOR

THE PLOS PUBLIC HEALTH IMPACT FACTOR IS A QUANTITATIVE MEASURE REFLECTING THE AVERAGE NUMBER OF CITATIONS TO RECENT ARTICLES PUBLISHED IN THE JOURNAL. AS A MEMBER OF THE PUBLIC LIBRARY OF SCIENCE (PLOS) FAMILY, PLOS PUBLIC HEALTH FOCUSES ON HIGH-QUALITY, PEER-REVIEWED RESEARCH THAT ADDRESSES GLOBAL PUBLIC HEALTH ISSUES. THE IMPACT FACTOR SERVES AS AN INDICATOR OF THE JOURNAL'S ACADEMIC INFLUENCE AND VISIBILITY WITHIN THE SCIENTIFIC COMMUNITY, SPECIFICALLY IN THE FIELD OF PUBLIC HEALTH.

IMPACT FACTORS ARE OFTEN USED BY RESEARCHERS TO ASSESS THE REPUTATION AND REACH OF A JOURNAL BEFORE SUBMITTING THEIR WORK OR CITING STUDIES. IN THE CONTEXT OF PLOS PUBLIC HEALTH, THIS METRIC HIGHLIGHTS HOW FREQUENTLY ITS PUBLISHED ARTICLES CONTRIBUTE TO ONGOING SCIENTIFIC DISCUSSIONS AND EVIDENCE-BASED POLICY-MAKING.

## OVERVIEW OF PLOS PUBLIC HEALTH JOURNAL

PLOS PUBLIC HEALTH PUBLISHES ORIGINAL RESEARCH, REVIEWS, AND POLICY ANALYSES COVERING A BROAD RANGE OF TOPICS INCLUDING EPIDEMIOLOGY, HEALTH POLICY, ENVIRONMENTAL HEALTH, AND SOCIAL DETERMINANTS OF HEALTH. ITS OPEN-ACCESS MODEL ENSURES THAT THE CONTENT IS FREELY ACCESSIBLE, FURTHER ENHANCING THE POTENTIAL CITATION AND IMPACT.

## ROLE OF IMPACT FACTOR IN ACADEMIC PUBLISHING

THE IMPACT FACTOR INFLUENCES SEVERAL ASPECTS OF ACADEMIC PUBLISHING, SUCH AS JOURNAL RANKING, AUTHOR DECISIONS, AND INSTITUTIONAL EVALUATIONS. FOR PLOS PUBLIC HEALTH, A STRONG IMPACT FACTOR UNDERSCORES THE JOURNAL'S COMMITMENT TO DISSEMINATING INFLUENTIAL PUBLIC HEALTH RESEARCH WORLDWIDE.

# CALCULATION METHODOLOGY OF THE IMPACT FACTOR

THE PLOS PUBLIC HEALTH IMPACT FACTOR IS CALCULATED BASED ON THE NUMBER OF CITATIONS RECEIVED IN A GIVEN YEAR FOR ARTICLES PUBLISHED IN THE PREVIOUS TWO YEARS, DIVIDED BY THE TOTAL NUMBER OF CITABLE ITEMS PUBLISHED DURING THOSE TWO YEARS. THIS STANDARD FORMULA IS WIDELY ADOPTED BY CLARIVATE ANALYTICS' JOURNAL CITATION REPORTS (JCR).

## FORMULA AND COMPONENTS

THE FORMULA FOR CALCULATING THE IMPACT FACTOR IS:

1. CITATIONS IN THE CURRENT YEAR TO ARTICLES PUBLISHED IN THE PREVIOUS TWO YEARS
2. DIVIDED BY THE NUMBER OF CITABLE ARTICLES PUBLISHED IN THE SAME TWO YEARS

FOR EXAMPLE, IF PLOS PUBLIC HEALTH ARTICLES PUBLISHED IN 2021 AND 2022 WERE CITED 2,000 TIMES IN 2023, AND THE JOURNAL PUBLISHED 500 CITABLE ARTICLES IN THOSE TWO YEARS, THE IMPACT FACTOR FOR 2023 WOULD BE 4.0 (2000/500).

## TYPES OF CITABLE ITEMS

CITABLE ITEMS GENERALLY INCLUDE ORIGINAL RESEARCH ARTICLES, REVIEWS, AND SOMETIMES EDITORIALS, BUT EXCLUDE ITEMS SUCH AS LETTERS OR NEWS PIECES. THIS DISTINCTION ENSURES THAT THE IMPACT FACTOR ACCURATELY REFLECTS THE INFLUENCE OF SUBSTANTIVE SCIENTIFIC CONTRIBUTIONS.

## SIGNIFICANCE OF THE IMPACT FACTOR IN PUBLIC HEALTH RESEARCH

THE PLOS PUBLIC HEALTH IMPACT FACTOR PLAYS A VITAL ROLE IN DEMONSTRATING THE JOURNAL'S CONTRIBUTION TO ADVANCING KNOWLEDGE IN PUBLIC HEALTH. IT SERVES AS A BENCHMARK FOR THE QUALITY AND RELEVANCE OF THE RESEARCH PUBLISHED AND HELPS GUIDE RESEARCHERS IN SELECTING APPROPRIATE JOURNALS FOR THEIR WORK.

## INFLUENCE ON RESEARCH VISIBILITY

A HIGHER IMPACT FACTOR GENERALLY CORRELATES WITH GREATER VISIBILITY AND HIGHER CITATION RATES, WHICH CAN ENHANCE THE DISSEMINATION OF IMPORTANT PUBLIC HEALTH FINDINGS. THIS VISIBILITY IS ESSENTIAL FOR TRANSLATING RESEARCH INTO PRACTICE AND POLICY.

## ROLE IN FUNDING AND CAREER ADVANCEMENT

MANY FUNDING AGENCIES AND ACADEMIC INSTITUTIONS CONSIDER THE IMPACT FACTOR OF THE JOURNALS WHERE RESEARCHERS PUBLISH AS PART OF GRANT EVALUATIONS AND PROMOTION CRITERIA. PUBLISHING IN A JOURNAL WITH A STRONG PLOS PUBLIC HEALTH IMPACT FACTOR CAN THEREFORE POSITIVELY INFLUENCE A RESEARCHER'S CAREER TRAJECTORY.

## FACTORS INFLUENCING THE PLOS PUBLIC HEALTH IMPACT FACTOR

SEVERAL FACTORS CAN AFFECT THE PLOS PUBLIC HEALTH IMPACT FACTOR, INCLUDING EDITORIAL POLICIES, PUBLICATION FREQUENCY, AND THE SCOPE OF RESEARCH TOPICS COVERED. UNDERSTANDING THESE FACTORS HELPS CLARIFY FLUCTUATIONS IN THE IMPACT FACTOR OVER TIME.

## EDITORIAL QUALITY AND PEER REVIEW

RIGOROUS PEER REVIEW AND HIGH EDITORIAL STANDARDS ENSURE THAT ONLY IMPACTFUL AND METHODOLOGICALLY SOUND RESEARCH IS PUBLISHED, WHICH CAN BOOST CITATIONS AND THE IMPACT FACTOR.

## OPEN ACCESS MODEL

THE OPEN-ACCESS NATURE OF PLOS PUBLIC HEALTH FACILITATES WIDER READERSHIP AND ACCESSIBILITY, OFTEN LEADING TO INCREASED CITATIONS COMPARED TO SUBSCRIPTION-BASED JOURNALS.

## RESEARCH TRENDS AND PUBLIC HEALTH PRIORITIES

EMERGING PUBLIC HEALTH CHALLENGES AND RESEARCH PRIORITIES CAN ALSO INFLUENCE CITATION PATTERNS. ARTICLES ADDRESSING TIMELY AND GLOBALLY RELEVANT TOPICS TEND TO ATTRACT MORE CITATIONS, AFFECTING THE IMPACT FACTOR POSITIVELY.

## COMPARISON WITH OTHER PUBLIC HEALTH JOURNALS

COMPARING THE PLOS PUBLIC HEALTH IMPACT FACTOR WITH THOSE OF OTHER PUBLIC HEALTH JOURNALS PROVIDES PERSPECTIVE ON ITS STANDING WITHIN THE FIELD. JOURNALS WITH SIMILAR SCOPES MAY HAVE VARYING IMPACT FACTORS BASED ON EDITORIAL STRATEGIES AND AUDIENCE REACH.

## LEADING JOURNALS IN PUBLIC HEALTH

## FREQUENTLY ASKED QUESTIONS

### WHAT IS THE CURRENT IMPACT FACTOR OF PLOS PUBLIC HEALTH?

AS OF THE LATEST 2023 JOURNAL CITATION REPORTS, PLOS PUBLIC HEALTH HAS AN IMPACT FACTOR OF APPROXIMATELY 5.2, REFLECTING ITS INFLUENCE IN THE PUBLIC HEALTH RESEARCH COMMUNITY.

### HOW DOES PLOS PUBLIC HEALTH'S IMPACT FACTOR COMPARE TO OTHER PUBLIC HEALTH JOURNALS?

PLOS PUBLIC HEALTH'S IMPACT FACTOR OF AROUND 5.2 PLACES IT AMONG THE MID-TO-HIGH TIER JOURNALS IN THE FIELD, INDICATING STRONG CITATION RATES COMPARED TO MANY OTHER PUBLIC HEALTH JOURNALS, THOUGH SOME SPECIALIZED JOURNALS MAY HAVE HIGHER SCORES.

### WHERE CAN I FIND THE OFFICIAL IMPACT FACTOR FOR PLOS PUBLIC HEALTH?

THE OFFICIAL IMPACT FACTOR FOR PLOS PUBLIC HEALTH CAN BE FOUND ON THE CLARIVATE WEB OF SCIENCE JOURNAL CITATION REPORTS WEBSITE OR ON THE JOURNAL'S HOMEPAGE, WHICH TYPICALLY DISPLAYS UPDATED METRICS ANNUALLY.

### DOES PLOS PUBLIC HEALTH HAVE AN IMPACT FACTOR DESPITE BEING AN OPEN-ACCESS JOURNAL?

YES, PLOS PUBLIC HEALTH IS AN OPEN-ACCESS JOURNAL AND IT DOES HAVE AN IMPACT FACTOR. OPEN-ACCESS STATUS DOES NOT PREVENT A JOURNAL FROM BEING INDEXED OR HAVING AN IMPACT FACTOR.

### HOW OFTEN IS THE IMPACT FACTOR FOR PLOS PUBLIC HEALTH UPDATED?

THE IMPACT FACTOR FOR PLOS PUBLIC HEALTH IS UPDATED ANNUALLY, USUALLY RELEASED IN JUNE EACH YEAR BY CLARIVATE'S JOURNAL CITATION REPORTS BASED ON THE PREVIOUS TWO YEARS OF CITATION DATA.

### WHAT FACTORS INFLUENCE THE IMPACT FACTOR OF PLOS PUBLIC HEALTH?

THE IMPACT FACTOR OF PLOS PUBLIC HEALTH IS INFLUENCED BY THE NUMBER OF CITATIONS ITS PUBLISHED ARTICLES RECEIVE WITHIN A TWO-YEAR PERIOD, THE JOURNAL'S PUBLICATION FREQUENCY, AND THE RELEVANCE AND QUALITY OF ITS RESEARCH CONTENT.
