

SEXTING WITH TEACHER

CRIMINAL CHARGES AND PENALTIES

TEACHERS FOUND GUILTY OF SEXTING WITH STUDENTS CAN FACE FELONY CHARGES, INCLUDING:

- POSSESSION AND DISTRIBUTION OF CHILD PORNOGRAPHY
- SEXUAL EXPLOITATION OF A MINOR
- SEXUAL MISCONDUCT OR ABUSE OF AUTHORITY
- PROFESSIONAL LICENSE REVOCATION

PENALTIES MAY INCLUDE IMPRISONMENT, FINES, MANDATORY REGISTRATION AS A SEX OFFENDER, AND PERMANENT DAMAGE TO PROFESSIONAL REPUTATION.

PSYCHOLOGICAL AND SOCIAL IMPACT

ESTABLISHING STRICT CODES OF CONDUCT AND CLEAR REPORTING PROCEDURES IS ESSENTIAL. SCHOOLS MUST HAVE TRANSPARENT POLICIES THAT DEFINE UNACCEPTABLE BEHAVIOR AND OUTLINE CONSEQUENCES FOR VIOLATIONS. PROVIDING SAFE AND CONFIDENTIAL CHANNELS FOR STUDENTS TO REPORT CONCERNS IS CRITICAL.

ROLE OF SCHOOLS AND COMMUNITIES

SCHOOLS AND COMMUNITIES PLAY A CRUCIAL ROLE IN ADDRESSING SEXTING WITH TEACHERS BY FOSTERING A SAFE ENVIRONMENT, SUPPORTING VICTIMS, AND PROMOTING ETHICAL BEHAVIOR AMONG EDUCATORS.

SUPPORT SYSTEMS FOR VICTIMS
