UNDERSTANDING CONSTRUCTION ACCIDENT LAW IN ST. LOUIS

CONSTRUCTION ACCIDENT LAW IN ST. LOUIS ENCOMPASSES THE LEGAL STANDARDS AND REGULATIONS DESIGNED TO PROTECT WORKERS IN ONE OF THE MOST DANGEROUS INDUSTRIES. DUE TO THE HIGH RISK OF INJURY, MISSOURI'S WORKERS' COMPENSATION LAWS AND VARIOUS FEDERAL REGULATIONS SUCH AS OSHA (OCCUPATIONAL SAFETY AND HEALTH ADMINISTRATION) STANDARDS APPLY RIGOROUSLY TO CONSTRUCTION SITES. UNDERSTANDING HOW THESE LAWS INTERACT IS ESSENTIAL FOR INJURED WORKERS SEEKING COMPENSATION AND FOR HOLDING NEGLIGENT PARTIES ACCOUNTABLE.

WORKERS' COMPENSATION AND CONSTRUCTION INJURIES

WORKERS' COMPENSATION IS THE PRIMARY SOURCE OF BENEFITS FOR INJURED CONSTRUCTION WORKERS IN ST. LOUIS. THIS NO-FAULT SYSTEM PROVIDES MEDICAL CARE, WAGE REPLACEMENT, AND DISABILITY BENEFITS WITHOUT REQUIRING PROOF OF NEGLIGENCE. HOWEVER, THERE ARE LIMITATIONS TO WORKERS' COMPENSATION, SUCH AS CAPS ON COMPENSATION AMOUNTS AND RESTRICTIONS ON FILING LAWSUITS AGAINST EMPLOYERS.

THIRD-PARTY LIABILITY CLAIMS

IN MANY CONSTRUCTION ACCIDENT CASES, INJURED WORKERS MAY HAVE GROUNDS TO FILE THIRD-PARTY LIABILITY CLAIMS. THESE CLAIMS TARGET PARTIES OTHER THAN THE EMPLOYER, SUCH AS EQUIPMENT MANUFACTURERS, SUBCONTRACTORS, OR PROPERTY OWNERS, WHOSE NEGLIGENCE CONTRIBUTED TO THE ACCIDENT. A ST. COMMON TYPES OF CONSTRUCTION ACCIDENTS

FALLS FROM HEIGHTS

FALLS ARE AMONG THE LEADING CAUSES OF SERIOUS INJURIES AND FATALITIES IN CONSTRUCTION. WORKERS MAY FALL FROM LADDERS, SCAFFOLDING, ROOFS, OR OTHER ELEVATED SURFACES WHEN SAFETY PROTOCOLS ARE NOT FOLLOWED OR WHEN EQUIPMENT IS DEFECTIVE.

STRUCK-BY ACCIDENTS

STRUCK-BY ACCIDENTS OCCUR WHEN A WORKER IS HIT BY FALLING OBJECTS, MOVING VEHICLES, OR CONSTRUCTION EQUIPMENT. THESE ACCIDENTS OFTEN RESULT FROM INADEQUATE SITE SAFETY MEASURES OR OPERATOR ERROR.

ELECTROCUTIONS

CONTACT WITH LIVE ELECTRICAL WIRES OR FAULTY EQUIPMENT CAN CAUSE ELECTROCUTION, LEADING TO SEVERE INJURIES OR DEATH. EMPLOYERS MUST ENSURE PROPER GROUNDING AND SAFETY TRAINING TO PREVENT SUCH INCIDENTS.

CAUGHT-IN OR BETWEEN ACCIDENTS

WORKERS CAN BE CAUGHT IN OR COMPRESSED BY MACHINERY, COLLAPSING STRUCTURES, OR TRENCHES. THESE ACCIDENTS TYPICALLY INVOLVE UNSAFE WORKING CONDITIONS OR LACK OF PROPER SAFETY GUARDS.

LEGAL RIGHTS OF INJURED CONSTRUCTION WORKERS

RIGHT TO PURSUE THIRD-PARTY CLAIMS

IN ADDITION TO WORKERS' COMPENSATION, INJURED WORKERS MAY SUE THIRD PARTIES RESPONSIBLE FOR THE ACCIDENT. THESE CLAIMS CAN PROVIDE COMPENSATION FOR PAIN AND SUFFERING, PUNITIVE DAMAGES, AND OTHER LOSSES NOT COVERED BY WORKERS' COMPENSATION.

PROTECTION AGAINST RETALIATION

MISSOURI LAW PROHIBITS EMPLOYERS FROM RETALIATING AGAINST EMPLOYEES WHO FILE WORKERS' COMPENSATION CLAIMS OR REPORT UNSAFE WORKING CONDITIONS. IF RETALIATION OCCURS, WORKERS MAY HAVE GROUNDS FOR ADDITIONAL LEGAL ACTION.
