MEDICAID AND FLORIDA HEALTHY KIDS

MEDICAID IS A STATE AND FEDERALLY FUNDED PROGRAM THAT OFFERS HEALTH COVERAGE TO ELIGIBLE LOW-INCOME INDIVIDUALS, FAMILIES, SENIORS, AND PEOPLE WITH DISABILITIES IN FLORIDA. CHILDREN'S MEDICAL SERVICES (CMS)

THE CMS NETWORK SERVES CHILDREN WITH SPECIAL HEALTHCARE NEEDS BY OFFERING COORDINATED MEDICAL CARE, CASE MANAGEMENT, AND ACCESS TO SPECIALISTS. THIS PROGRAM IS CRITICAL FOR FAMILIES REQUIRING LONG-TERM MANAGEMENT OF CHRONIC CONDITIONS OR DISABILITIES.

MEDICARE AND PRESCRIPTION DRUG ASSISTANCE

HOUSING ASSISTANCE PROGRAMS
