SOCIOECONOMIC DISPARITIES IN ELITE COLLEGE ADMISSIONS

ACCESS TO RESOURCES AND OPPORTUNITIES

WEALTHIER APPLICANTS BENEFIT FROM PRIVATE TUTORING, TEST PREPARATION COURSES, AND LEGACY CONNECTIONS THAT IMPROVE THEIR CHANCES OF ADMISSION. THESE ADVANTAGES CREATE AN UNEVEN PLAYING FIELD, WHERE MERITOCRACY IS UNDERMINED BY FINANCIAL PRIVILEGE. THE DISPARITY EXTENDS BEYOND ACADEMICS TO INCLUDE OPPORTUNITIES FOR LEADERSHIP ROLES, COMMUNITY SERVICE, AND OTHER EXTRACURRICULAR ACHIEVEMENTS THAT ELITE COLLEGES HIGHLY VALUE.

FINANCIAL BARRIERS AND APPLICATION COSTS

APPLICATION FEES, CAMPUS VISITS, AND OTHER RELATED EXPENSES CAN DETER QUALIFIED LOW-INCOME STUDENTS FROM APPLYING. EVEN WITH FEE WAIVERS, THE CUMULATIVE COSTS OF APPLYING TO MULTIPLE ELITE INSTITUTIONS CAN BE PROHIBITIVE, LIMITING THE APPLICANT POOL AND REINFORCING SOCIOECONOMIC EXCLUSION.

LEGACY PREFERENCES AND THEIR IMPACT

LEGACY ADMISSIONS POLICIES, WHICH GIVE PREFERENTIAL TREATMENT TO APPLICANTS WITH FAMILY TIES TO ALUMNI,

CONTRIBUTE SIGNIFICANTLY TO THE REAL PROBLEM WITH ELITE COLLEGE ADMISSIONS. THESE POLICIES ARE OFTEN CRITICIZED FOR PERPETUATING PRIVILEGE AND REDUCING OPPORTUNITIES FOR FIRST-GENERATION AND UNDERREPRESENTED STUDENTS.

HISTORICAL CONTEXT OF LEGACY ADMISSIONS

ORIGINALLY INTENDED TO FOSTER ALUMNI LOYALTY AND FINANCIAL SUPPORT, LEGACY PREFERENCES HAVE EVOLVED INTO A CONTROVERSIAL PRACTICE THAT DISPROPORTIONATELY BENEFITS AFFLUENT AND PREDOMINANTLY WHITE FAMILIES. CONSEQUENCES OF THE CURRENT ADMISSIONS SYSTEM
