OVERVIEW OF THE WESTWOOD BOARD OF EDUCATION

THE WESTWOOD BOARD OF EDUCATION SERVES AS THE PRIMARY GOVERNING BODY FOR THE PUBLIC SCHOOLS WITHIN THE WESTWOOD AREA. IT IS TASKED WITH ESTABLISHING EDUCATIONAL GOALS, IMPLEMENTING POLICIES, AND ENSURING COMPLIANCE WITH STATE AND FEDERAL REGULATIONS. HISTORY AND MISSION
